### What does it mean to serve on a Board of Directors?

#### The Board of Directors Duties Include:

- Setting the vision and direction of the organization
- Representing the organization with integrity and loyalty to its mission and vision
- Providing oversight and guidance to the executive director and other staff members
- Legal, management, financial, and program oversight
- Fundraising
- Ensuring that the organization stays aligned with its mission and values in addition to complying with all federal and state laws

### What would be requested of you?

- Serve as a board member for at least one year
- Attend monthly meetings, each fourth Wednesday of the month from 4:30 to approximately 6:00
- Help with fundraisers
- Join and participate in at least one committee:

Executive Committee (finance and personnel)

Organizational Development

Fund Development

Public Relations

- Make a financial contribution (*It is proven that many donors select to contribute only to organizations with 100% board participation*)

### How much of your time would be required?
